50.04 Approval of two years M.A. Education Program (ICFAI Education School)

The Chairman, BoS presented the proposal for offering of M.A. Education program from the Academic Session 2022-23.

The Academic Council was apprised of the recommendations of the Board of Studies.

Recommendations:

The Academic Council approved in principle the proposal to offer M.A. Education (2 Years) program by ICFAI Education School from the Academic Year 2022-23 along with the course structure and other recommendations. The Academic Council made the following suggestions.

- A project report be prepared indicating the fee structure, requisite infrastructure and Faculty, student intake, process of taking approval from the recognizing body, prospects of the program and its futuristic stability.
- Formal information be sent to the University Grant Commission for starting M.A.
 Education at The ICFAI University enclosing the resolution passed by the Board of Governors.
- The Core Papers mentioned in the syllabi should be of 4 Credits and Dissertation of 12 Credits. The latest UGC Notification, dated 18th November, 2021 can be referred while allocating the credits. All departments should download the same and incorporate the necessary details into the curriculum.
- Applied Courses Syllabus should be in sync with the NET Syllabus so that the students are benefitted when they appear for the NET Examination after completion of their Post-Graduation.

The Chairman is advised to revise the Course Structure and finalize it keeping in view the above suggestions.

50.05 Approval of two year LL.M. program with its program structure and syllabus with two specializations: (ICFAI Law School)

- Corporate and Commercial Law
- Constitutional and Administrative Laws

The Asst. Dean of Law presented the proposal to offer LLM (2 years) program from the Academic Year 2022-23.

Recommendations:

The Academic Council approved in principle the proposal to offer LLM (2 years) program from the Academic Year 2022-23. The Academic Council made the following suggestions:

- The curriculum is to be reassessed, revised and revamped.
- The nomenclature of Core and Elective Papers be made more clear.
- The arrangement of core content needs to be streamlined further.
- Core papers should have 6 Credits, Elective papers 4 credits and Dissertation 12 credits
- The Applied Legal Course with Dissertation should be included in LLM with a syllabus which is in sync with the NET syllabus so that students are better placed while appearing for the NET Examination.
- The Program outcome should be prepared as per Bloom's Taxonomy.
- The above suggestions be incorporated and a revised curriculum be prepared and same be circulated to all the members.

50.06 Review of Curriculum and Syllabus of MBA Program (ICFAI Business School)

The Associate Dean, IBS presented the revised Curriculum and Syllabus of MBA Program and appraised the Council of the recommendations of the Board of Studies.

Recommendations:

The Academic Council approved the proposal to change the nomenclature of the courses as proposed by Board of Studies of IBS and include the relevant provisions of labour code in "Legal Environment of Business".

50.07 Review of curriculum and syllabus of Bachelor of Business Administration in Tourism & Travel Management

The Academic Council after discussion on the recommendations of BoS of IBS pertaining to BBA in Tourism and Travel Management program resolved to defer the proposal to offer the program for the time being since Tourism and Travel Management is the worst affected sector due to Covid -19 pandemic and it is difficult to attract the students for the program at present.
