- c) ILS should maintain the teacher's hierarchy as 1:2:4 (Professor: Associate Professor: Assistant Professor)
- d) IUD should follow the admission academic calendar for smooth execution of academic process.
- 2. Dr. A. V. Vedpuriswar suggested to renovate the IUD computer laboratories.
- 3. Dr. Damodar Reddy inquired about the balance semester fee. He was informed by the Registrar about the steps taken to reduce dues and informed that by first week of April, most of dues would be recovered.
- 4. The VC informed that futuristic industry oriented, Integrated programs such as B.Tech.
- L.L. B, B.Sc.- L.L.B, B.A B.Ed. & B.Sc. B.Ed. and B.A. Psychology would be

considered for induction.

5. The VC also suggested the induction of the University Fellowship to enhance the research eco-system of the IUD.
