Report of the Anti Ragging Committee

The Anti Ragging Committee of The ICFAI University, Dehradun have received a complaint of ragging from a student of ICFAI University on 26th January, 2019 vide Ref No. ARCC/ UK-5165. On The same day i.e. 26th January, 2019 University authorities enquired into the matter and called the students who were involved in this matter and asked from the complainant to proceed to file a First Information Report (FIR) before the police station. But the complainant refused to file an FIR and said that he had made the complaint under the influence of other students. He said that he wanted to withdraw his complaint.

The fact of the case mentioned in the complaint of victim is about ragging by accused student of BA-LL. B. 3rd Year, Pranay Aggrawal, Sourabh Kumar and Nitesh Tiwari is as follows-

Annual Cultural Fest organized by the ICFAI University, Dehradun in its campus from 24-25th January, 2019. On 25th January in night there was a celebrity performance. During this fest the above mentioned named of accused students (Pranay Aggrawal, Sourabh Kumar and Nitesh Tiwari) were the part of disciplinary committee constituted for the fest to maintain the decorum of the students in the campus for smooth functioning of the cultural fest. After the performance of the celebrity few outside students were gathered at the gate of the University and started creating a nuisance by using abusive languages in the state of drunk, quarreling with each other and there was a scuffle. Complainant was also there in the crowd his specs were broken down in this event. Complainant was not able to identify the students in the crowd and when he asked the names of students who had pushed him. His batch mates and seniors gave the names of the accused students (Pranay Aggrawal, Sourabh Kumar and Nitesh Tiwari) and also suggested to file a complaint in the Anti Ragging Cell. The accused pointed out to the fact that at that time they were inside the campus.

The committee have listened the views and grievances of victim. We have examined the letter of complainant regarding the issue of fight among students dated 25th January, 2019. There was no bodily injury or serious scratches on the body of the victim. On 26th January, 2019 i.e. the day of the complaint filed by complainant (victim), Victim already sent a mail to the Registrar of the ICFAI university and In-Charge ICFAI Law School that mistakenly and other's influence he had filed a complaint in the Anti Ragging Cell. The Statement of the victim in his own hand writing was received. He was examined and counseled. He apologized and assured that not to file such frivolous complaint in future. The accused were called before Anti Ragging Committee. They were examined and counseled. The accused and the complainant gave their written statement. All the students told the committee that it is not a case of ragging but a case of scuffle among outside students in the crowd. All the students submitted a joint letter that they have no issues among themselves and they will maintain the discipline in the future.

Conclusion:

On the basis of the fact and circumstances, it has been decide by the anti ragging committee that it is not a case of ragging, but a case of scuffle among the unknown students in the crowd. The matter has been shifted to the Proctorial Board and Disciplinary Committee of the ICFAI University, Dehradun for strict disciplinary action against the students who were involve in the quarrelling and creating nuisance near the campus gate.
